- Serves as an orientation overview of the Honors program
- 3 credit course
- Meets all necessary requirements
- To be the one required course in the Honors program for traditional students
- Transfer students will be exempt

Bylaws (voted on and passed unanimously):

- Addition of AFLS 1023H as the only required course
- 9-12 course hours plus 3-6 thesis hours for a total of 15 total hours.

Subcommittee Report:

Student Incentives:

- Service Learning Activities
- Record their work in the UA Volunteer Action Center

Faculty Incentives:

• \$1000.00 bonus to each faculty mentors income for each student graduated through the Honors Program as income.

Honors Thesis Competition:

Discussion of suspending the program.

Strict deadlines in place that if you do not meet you will be dropped from the program. The number of students with a finished thesis at the time of the thesis competition is so small.

Requirements must be consistent throughout the years.

Selection of qualified faculty judges to judge the competition.

Solid rubric must be in place.

Evaluated based on completed theses.

Monetary awards in place for winners.

If students do not meet standards, then no awards will be awarded.

In the past, the quality of the projects has been marginal at times, we should shift focus to improving the quality of projects.

Evaluation over time is difficult with changing faculty. Even with a solid rubric, it is difficult to be consistent.

The thesis competition allows top students to create a track record for success. Students who excel do it for the awards/metals. Focus should be on the other perks of being in Honors.
