Form 3 requires signatures from committee. If electronic signatures not possible, will need confirmation (email) from faculty mentor that all members voted and the student received a pass.

For submission, mentor and student need to sign form for upload and indicate immediate or delayed uploads.

Deadlines for completion and thesis submission are currently somewhat relaxed, but May 1, 2020 (dead day) is an absolute deadline for thesis upload. If later, the student will be considered for summer graduation.
